LETTER OF INVITATION

Subject: Invitation of bids for ‘Selection of Agency for evaluation of Rajiv Gandhi Grameen Viduytikaran Yojna (RGGVY)’

1. Rajiv Gandhi Grameen Vidyutikaran Yojana (RGGVY) a flagship programme of Government of India aims at electrification of un-electrified villages and providing access to electricity to all rural households in the country, including electrification of un-electrified habitations with a population of above 100 and providing free electricity connections to BPL households. The scheme, launched in April, 2005, for implementation in X-Plan is now continued in XI-Plan also.
2. Rural Electrification Corporation Limited (REC), a Government of India Enterprise under the Ministry of Power (MoP), is the nodal agency for implementation of the scheme in entire country.
3. REC intends to appoint an agency for evaluation of the scheme RGGVY.
4. You are invited to submit your Proposal for providing your services for evaluation of RGGVY
5. The following documents are enclosed to enable you to submit the proposal:
 - a. Letter of Invitation Data Sheet (**Annexure-I**)
 - b. Terms of Reference (TOR) (**Annexure-II**)
 - c. Supplementary Information (**Annexure-III**)
 - d. Format of Bank Guarantee for Bid Guarantee (**Annexure-IV**)
 - e. Formats for Proposal (**Form No. F-1 to F-9**)

6. Submission of Proposal:

The bidder, while submitting their proposal, should furnish information in the prescribed forms as contained in the 'Supplementary Information':

- (i) The proposal must be submitted in sealed envelope with covering letter as per the **Form No. F-I** (in accordance with the formats/schedules given in the 'Supplementary Information')

Each page of the proposal should be signed by the bidder.

- (ii) The proposals should be submitted in 3 copies (one original and 2 copies). The envelopes shall be marked 'ORIGINAL', 'COPY No. 1' and 'COPY No.2' as applicable. Proposals shall be submitted to **Additional General Manager(RGGVY), Rural Electrification Corporation Limited, Core-4, SCOPE Complex, No.7, Lodhi Road, New Delhi-110003**, up to 15:00 hours of 18.08.2010. Offers received after the due date and time shall not be considered for reasons whatsoever.
7. Opening of Proposal: The proposals will be opened at 15:30 Hrs. on the same day in the presence of such bidders or their authorized representative who would like to attend the Bid Opening.
8. Bid Evaluation: Bidders meeting the selection criteria only shall be considered for the consultancy work. The bidders shall quote for the complete services as per Terms of Reference. Bidders quoting for partial or incomplete services run the risk of rejection.

9. **SELECTION CRITERIA**

The agency must satisfy the following criteria for consideration of award of this assignment:

- (i) The Agency must be a registered legal entity in India. An individual or group of individuals or organization which is legally permitted to enter into a contract, and be sued if it fails to meet its contractual obligations.
- (ii) The Agency must have turnover of minimum Rs 2.0 crore in at least one of last three financial years. The Agency must submit audited Annual Accounts for last 3 financial years ending March 31st 2009.
- (iii) The Agency must have completed at least one single work of similar nature of value not less than Rs 15.0 Lakh (Rupees Fifteen Lakh Only) during the last 5 years ending last day of month previous to the one in which bids are invited.
- (iv) The Agency must have minimum 5 experienced full time professionals.
- (v) The Agency must have assisted State Government/Central Government/ any other Governmental body in carrying out such evaluation work.
- (vi) The Agency should have sound understanding of the legal and regulatory framework governing the power sector, sound technical knowledge base of power sector and socio-economic sector.
- (vii) The Agency will be required to work in close coordination with REC field offices/ Corporate Office, New Delhi.

In order to demonstrate satisfactory compliance of the above criteria, the Agency must submit the documentary proof. Bidders are advised to give complete information and documentary evidence regarding Selection Criteria at the first instance. Bidders not submitting complete information/documents at first instance run the risk of rejection.

10. Financial Proposals of only such firms will be considered whose offers shall meet the selection criteria.
11. The documents mentioned above, including this Letter of Invitation will form part of the Tender Documents. Each of the documents in line with tender requirements shall be submitted duly stamped & signed on each page by the authorized representative of the bidder which shall also constitute bid. The bid is to be submitted in a sealed envelope with all referred superscription i.e. the name of the work, due date & time, Bidders Name & Address.
12. Contract Performance Guarantee (CPG): In the event of an award, the successful Bidder (Agency), within fifteen days of receipt of the Letter of Award from REC, will be required to arrange submission of the CPG in the form of a Bank Guarantee (BG) equivalent to 10% (Ten Percent) of the contract consideration. The CPG/BG shall be as per Performa (will be given to the successful bidder) and initially kept valid up-to the completion of the assignment plus 6 months.
13. Basis of Price offer: The Price Offer shall be for the assignment as per **Annexure-I** of Bid Proposal Sheet and the Terms of Reference and shall remain FIRM throughout the period of contract. Quoted Price will be on a lump-sum basis inclusive of all travel, stay, out of pocket expenses, cost of producing documents etc. and REC will not pay and/or reimburse anything over and above the price quoted. Office accommodation, transport and daily movement of Agency's professionals, telephone, computer and other facilities shall be arranged by the Agency at its own cost. The prices shall be exclusive of taxes and duties on transaction between bidder/Agency & REC, which will be reimbursed at actuals. In the event of an award of contract, income tax will be deducted by REC at source as per law and Tax Deduction at Source Certificate shall be issued to the Agency by REC. **Price offer strictly must be in the format given in Form No. F-9.**
14. Time Schedule/Completion Period: The Agency is required to submit the following deliverables during the course of the assignment as per following schedule:

- The draft report shall be reviewed/commented by REC and the selected Agency shall give revised final draft within 1 week of the comments of REC.
- The Agency shall also provide a soft copy of the initial as well as the final draft of all the deliverables including presentations.

15. Signing of Formal Contract Agreement : In the event of an award, the successful Bidder shall be required to enter in to a Contract Agreement with REC within 15 (Fifteen) days from the date of the Letter of Award (LOA)/Letter of Intent(LoI) or within such extended time as may be granted by REC.
16. Validity of Bid: Bidders have to keep their Bids / Quotations valid up to 180 days for acceptance from the date of opening of the Proposals.
17. Bid Guarantee/Earnest Money Deposit (EMD): Bid Guarantee /EMD of INR 50,000 (Indian Rupees Fifty thousand only) in the form of Demand Draft/Bank Guarantee (as per format enclosed at **Annexure-IV**) in favour of REC Limited, payable at New Delhi shall accompany the Bid for the assignment. Bids received without Bid Guarantee/EMD shall be rejected. The Bid Guarantee/EMD will be refunded to the successful Bidder, after signing of the Contract and submission and acceptance of Contract Performance Guarantee. The Bid Guarantee/EMD of all unsuccessful Bidders shall be returned within thirty (30) days of acceptance of Contract Performance Guarantee of the successful bidder.

 - (iv) 20% of the Contract Value - After submission of final report and completion of the assignment to the satisfaction of REC.

TERMS OF REFERENCE

**TERMS OF REFERENCE FOR EVALUATION OF Rajiv Gandhi
Grameen Vidyutikaran Yojana (RGGVY)**

1. Background

Government of India, in April 2005, launched the scheme 'Rajiv Gandhi Grameen Vidyutikaran Yojana – Scheme of Rural Electricity Infrastructure and Household Electrification' for electrification of un-electrified villages and providing access to electricity to all rural households in the country, including electrification of un-electrified habitations with a population of above 100, providing free electricity connections to BPL households.

REC is the nodal agency for implementation of the scheme in entire country.

Initial approval was for implementation of Phase-I of the scheme for capital subsidy of Rs 5000 crore during the 10th Plan period. The scheme was subjected to evaluation towards the end of 10th Plan with a view for assessing modification required for implementation during 11th Plan.

Accordingly, approval for continuation of the scheme in XI Plan was issued by Ministry of Power vide OM No. 44/37/07-D(RE) dated 6th February 2008 with capital subsidy of Rs 28000 crore during 11th Plan period.

Salient features

- Ninety per cent capital subsidy is provided towards overall cost of the projects under the scheme.
- For projects to be eligible for capital subsidy under the scheme, prior commitment of the States be obtained before sanction of projects under the scheme for:
 - i) Guarantee by State Government for a minimum daily supply of 6-8 hours of electricity in the RGGVY network with the assurance of meeting any deficit in this context by supplying electricity at subsidized tariff as required under the Electricity Act, 2003.
 - ii) Deployment of franchisees for the management of rural distribution in projects financed under the scheme and to undertake steps necessary to operationalize the scheme.
- The management of rural distribution would be through franchisees who could be Non- Governmental Organizations (NGOs), Users Association, Panchayat Institutions, Cooperatives or individual entrepreneurs. The franchisee should be preferably input based to reduce AT & C losses so as to make the system revenue sustainable.
- The projects under the scheme are subject to three-tier Quality Monitoring Mechanism. At first tier, implementing agency will engage third party inspection agency to inspect approx. 50% villages on random sample and pre-dispatch inspections of major materials. Whereas at Second tier, Rural Electrification Corporation will engage REC Quality Monitors to inspect 10% villages on random sample basis. At third tier, National Quality Monitors will be engaged by the Ministry of Power to cover evaluation of 1% villages.

Cumulative performance

- a. The total coverage under the RGGVY from the date of launching the programme is as mentioned below:-

- b. Cumulatively, works in 208111 villages (80864 un-electrified and 127247 electrified villages) have been completed under RGGVY up to 15.06.2010. Cumulatively, connections to 128.28 lakh rural households including 115.53 lakh BPL households have been released under the scheme up to 15.06.2010.

REC intends to appoint an Agency for evaluation of the scheme 'Rajiv gandhi Grameen Vidyutikaran Yojana' and is therefore, inviting interested parties to submit their proposals to REC.

2. Objective of the Assignment

Rural Electrification Corporation Limited (REC), a Government of India enterprise under the Ministry of Power, is the nodal agency for implementation of the scheme in entire country. REC intends to appoint an Agency for evaluation of the scheme 'Rajiv gandhi Grameen Vidyutikaran Yojana' and is therefore, inviting interested parties to submit their proposals to REC in accordance with the Terms and Conditions specified in this Terms of Reference.

3. Scope of work: The Scope of work for the assignment shall be as follows:

- a. This assignment comprises evaluation of RGGVY in the following states:
- Assam
 - Orissa
 - Gujarat
 - Bihar
 - Jharkhand
 - Chhattisgarh
 - Madhya Pradesh
 - Tamilnadu
 - Uttar Pradesh
 - Haryana

- b. The evaluation of RGGVY would be through detailed survey of minimum 50 villages spreading across atleast 5 districts in respect of each of the above states.
- c. The assignment of evaluation study through detailed survey of RGGVY works shall cover the following:
 - 1. To assess whether the villages wherein works have been completed under RGGVY fulfill the new definition of village electrification.
 - 2. To assess status of power supply in the villages electrified under the scheme. The status should cover quantity i.e. duration of electricity supply hours per day & clock time of availability of power and quality i.e. reliability & proper voltage. Status of power supply should also to be assessed for already electrified villages where intensive electrification works have been completed under the scheme and bring forth any improvements in quality and quantity of power supply vis-à-vis prior to this scheme's implementation.
 - 3. To assess whether the infrastructure created under the scheme is adequate to cater the near future demand of the area and quality of infrastructure provided is satisfactory. To bring forth the deviations in implementation, if any, from that of the approved proposals of the scheme.
 - 4. To ascertain the scope and coverage in terms of villages, habitations and BPL households as per approved proposal under the scheme and deviations in implementation, if any.
 - 5. To assess whether the capacity of backup sub-transmission and transmission system is adequate to cater to load demand created under the scheme.
 - 6. To assess whether appropriate arrangement have been made by the concerned state power utility for operations & maintenance of infrastructure created, billing & revenue collection from households electrified under the scheme and status of further load development in the project areas in non-domestic categories for productive use of electricity.
 - 7. To assess whether Franchisee's have been deployed to the scheme area; to critically evaluate their working and impact of the franchisee arrangement.

In the absence of franchisee arrangement under the scheme area, to suggest possible interventions required.

8. To assess and analyse reasons for delays, if any - with respect to pre-set timelines, in implementation of projects and to identify the constraints in implementation viz., Manpower, Administrative, Technical, Financial, Social, Market *et al.*
9. To assess the degree of enthusiasm among the villagers and particularly the BPL families in coming forward to avail the electricity connections under this scheme and their capability/affordability in payment of electricity consumption charges.
10. To assess the additional investment requirements to achieve the objective of providing electricity to all.
11. To assess the impact of rural electrification on socio-economic aspects with specific reference to the following:
 - i. Income generation (among rural populace)
 - ii. Education
 - iii. Health
 - iv. Economic opportunities (floor mills, cold storage, village industries, etc.)
 - v. Employment
 - vi. Safety & security
 - vii. Migration to urban areas
 - viii. Comfort and satisfaction
 - ix. Quality of life
- d. To suggest a way forward
- e. To submit detailed report of the evaluation of RGGVY alongwith all relevant information including tables/charts/photographs, etc within the timeframe stipulated.
