### CIRCULAR

Sub: - Contributory Scheme for Post Retirement Medical Facilities-Clarifications

In continuation of Part-III Office Order No.46 dated 11.09.2009 on the captioned subject it has been felt necessary to issue certain clarifications for the sake of uniformity as under:

S.NO.	ISSUES	CLARIFICATION
I.	<b>Eligible employee who have separated from the corporation on or after 01.04.2009.</b>	
i)	As the revised provisions are effective from the financial year 2009-10 whether the balance amount of subscription already submitted as per pre revised rates( Last basic pay) has to be refunded after adjustment of revised subscription amount of Rs.1500 (one time payment).	Yes.
II.	<b>Existing members of the scheme who have opted for annual subscription @ 10% of last basic pay in terms of pre-revised Rule 4(i) of the Scheme.</b>	
i)	As the provision for annual membership subscription has been discontinued and in terms of revised rules one time payment of Rs.1500 is required to be made, whether the existing members are required to continue annual payments or make one time payment of Rs.1500/- .	In view of the revised provisions, the existing members who are yet to submit their annual subscription may make one time subscription of Rs.1500/-.
ii)	Whether the annual	Yes.

	subscriptions due on or after 01.04.2009 and already paid at pre revised rates (prior to issue of the clarifications) are to be refunded after adjustment of one time payment of Rs.1500/-.

<b>III.</b>	<b>Eligible employees who have separated from the corporation before 01.04.2009 but have become members on or after 01.04.2009.</b>	
	Whether the subscription amount already submitted by them at pre revised rates will be refunded to them after adjustment of revised subscription amount of Rs.1500 (one time payment).	As the membership amount has been revised w.e.f 01.04.2009 hence the difference is required to be refunded.
