Sir,

1. REC invites limited NIT for “Fabrication of Addl. Cabin at 4th Floor of REC’s Office at Scope Complex, Core-4, Lodhi Road, New Delhi – 110 003” with an estimated cost of work for an amount of Rs.80,233/-(Rupees eighty thousand two hundred thirty three only).
2. The Last date of submission of bid is 24.03.2009 upto 3.00 PM and the same shall be opened on the same day at 3.30 PM in the presence of the bidders or their representatives who choose to participate in the bid opening.
3. The bidder is required to submit the Copy of Registration Certification from C.P.W.D./MES/MCD/NDMC/Railways or any other Central/State Government Agencies where the bidder is enlisted, experience certificate indicating the completion of similar work along with VAT Registration/Service Tax and PAN.
4. Interested Bidder are required to submit an Earnest Money of **Rs 5,000/- (Rupees five thousand only) through** Demand Draft/Bankers Cheque of a Scheduled Bank in favour of Rural Electrification Corporation Ltd along with the bids. Bids without EMD shall be rejected. EMD of the un-successful bidders shall be returned after award of work to the successful bidder. EMD of the successful bidder shall be adjusted towards security deposit.
5. Tender shall be submitted in sealed envelope superscribing ““Fabrication of Addl. Cabin at 4th Floor of REC’s Office at Scope Complex, Core-4, Lodhi Road, New Delhi – 110 003” & will be received in the Estate Division of Rural Electrification Corporation, Core-4, Scope Complex, 7-Lodhi Road, New Delhi – 110 003.

6. Bidders are advised to visit site and its surroundings and satisfy in their own interest before submission of their bids
7. Bidders shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charges consequent on any misunderstanding or otherwise shall be allowed.
8. Bidders shall quote his rates as per Schedule of quantities available in enclosed **Annexure-I**. Bidders shall quote their Rates as firm and all inclusive.
9. The **time allowed** for carrying out the work will be **Ten days** from the seven day after the date of written orders to commence the work or from the first day of handing over of the site, whichever is later. The working hours shall be from 7 PM to 5 AM on all working days and on Sat/Sun/Holidays shall be from 9 AM to 6 PM.
10. **Payment Terms:-** No advance shall be given and payment shall be made after completion of the work.
11. **Security Deposit :** - A sum of 5% of the executed works shall be deducted from the payment towards security deposit which shall be refunded after completion of the defect liability period which is six months after completion of the work.
12. **Liquidated Damages :-** For delay in completion of the work, the liquidated damages @ 0.25% per week or part thereof subject to the maximum of 5% of the order value shall be deducted.
13. All works shall be carried out as per Specifications.
14. Bidders shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a tender by Bidders implies that he has read this notice and has made himself aware of the scope and specifications of the work to be done and of conditions and other factors having a bearing on the execution of the work.
15. The competent authority on behalf of the REC does not bind itself to accept the lowest or any other tender and reserves to itself the authority to reject any or all the tenders received without the assignment of any reason. All tenders in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the Bidder shall be summarily rejected.

16. Canvassing whether directly or indirectly, in connection with tenders is strictly prohibited and the tenders submitted by the bidders who resort to canvassing will be liable to rejection.
17. Agreement shall be drawn with the successful Bidders on prescribed format. The competent authority on behalf of REC reserves to himself the right of accepting the whole or any part of the tender and the bidder shall be bound to perform the same at the rate quoted.
18. The tender for the works shall remain open for acceptance for a period of sixty days from the date of opening of tenders. If any bidder withdraws his tender before the said period or issue of letter of acceptance, whichever is earlier, makes any modifications in the terms and conditions of the tender which are not acceptable to the Corporation, then the Corporation shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the said earnest money as aforesaid.
19. This Limited Notice Inviting Tender shall form a part of the contract document. The successful bidder/contractor, on acceptance of his tender by the Accepting Authority, shall, within 07 days from the stipulated date of start of the work sign the contract agreement including notice inviting tender, all the documents including additional conditions, specifications and drawings, if any, forming the tender as issued at the time of invitation of tender and acceptance thereof together with any correspondence leading thereto.
