Balance Sheet

- Total Assets increased by 28.68% from Rs. 52,083 Crores to Rs. 67,021 Crores.
- Outstanding Borrowings increased by 24.51% from Rs. 44,936 Crores to Rs. 55,948 Crores.
- Net worth increased from 6,190 Crores to 11,080 Crores.

Income Statement

- Operating Income increased by 37.69% from Rs. 4,757 Crores to Rs. 6,550 Crores.
- NII increased by 42.53% from Rs. 1,768 Crores to Rs. 2,520 Crores.
- Profit before tax increased by 37.97% from Rs. 1,920 Crores to Rs. 2,649 Crores.
