<p>Point B (ii) Technical Bid -should be duly certified by the statutory auditor / external chartered accountant</p> <ul style="list-style-type: none">▪ Can we submit the scanned copy of the auditor certificate duly stamped & signed by the authorized signatory certifying it to be true copy▪ In case Annual Report/ Balance Sheet is already certified by the Statutory Auditor, do we still need to furnish a certificate from the Auditor or the figures mentioned in the Annual Report of the financial year ending March 31, 2011 would suffice.	<p>The scanned copy of the auditor certificate duly stamped & signed by the authorized signatory, certifying it to be true copy may be submitted as a proof thereof</p> <p>In case the AUM figures are part of the Financial Statements, duly certified by the Statutory Auditors, we may rely on the same and separate certification from the Statutory/ External Chartered Accountant may not be required. The figure should separately identifiable.</p> <p>However, in case the same is part of the Annual report which is not certified by the Statutory Auditor, then a separate certificate from the Statutory Auditor/ External Chartered Account will be required.</p>
<p>Point B (iv) Technical Bid – Historical return / interest rate declared under capital & return guaranteed scheme</p> <ul style="list-style-type: none">▪ You have asked for historical return /interest declared under capital & return guaranteed scheme. Please clarify if you want returns for fund/ products which have both capital & return guarantee or do you want it for product / fund that have capital and/or return guarantee.▪ Can we quote the returns of the Gratuity product offering only capital guarantee▪ Also can we quote the returns of the product not offering any capital or return guarantee?	<p>The NIT is quite clear by itself that we have asked for historical return/ interest declared for funds/ products which have both capital & return guarantee.</p> <p>No. However any additional information may be given as a separate Annexure to the Bid document duly certified by the Authorized Signatory.</p> <p>No. However any additional information may be given as a separate Annexure to the Bid document duly certified by the Authorized Signatory.</p>
