- 1) Sealed Quotation should be sent to AGM (IT), IT Division, 1st Floor, REC Limited, Core 4, SCOPE Complex, 7-Lodhi Road, New Delhi – 110 003 on or before 06-12-2011 3:00 PM.
- 2) Quantity as indicated in this document is subject to change determined by the needs of the RECL. The payment would be made as per actual.
- 3) Decision of RECL is final and binding upon the bidders for the placing of orders.
- 4) The RECL reserves the right to reject lowest quotation or all the quotations or accept any quotation or part thereof without assigning any reason.

- 5) **Delivery term:** Within 3 days of issue of the Purchase Order. However, vendor will be requested for early supply.
- 6) **Evaluation Quotation:** Quotation will be evaluated on the basis of lowest quote (LQ1) in for Grand Total, however arithmetical errors will be rectified on the following basis: If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected. If the supplier does not accept the correction of errors, its bid will be rejected.
- 7) **Payment terms :**
- a. No advance payment shall be made.
 - b. Payments shall be subject to deductions of any amount for which the Vendor is liable as per tender. Further, all payments shall be made subjects to deduction of TDS (Tax deduction at Source) as per the prevailing income- Tax Act and any other taxes as on the date of invoice submission and/or payment date, whichever is higher.
 - c. 80 % payment on successful delivery and installation and commissioning at the destination/ location as mentioned in the Purchase Order.
 - d. Balance 20 % payment after one month of successful performance at places of installation. During this one month period, it is essential to have no complaint from the end user regarding performance / shortcoming of the installed systems.
- 8) **Penalty for Delays:**
- a. Time is essence of the contract. The successful bidder must supply, install, test and commission all the equipments within stipulated time period of entrustment of the order. Failure to supply or commission all or some of the equipment(s) on or before the stipulated date will entail a penalty equal to 1.5% of the value of contracted Package price per week subject to maximum of 10% of total contract value or part thereof. Payment of liquidated damages does not affect the successful bidder's liabilities.
 - b. In the case of delay in compliance with the order beyond 10 days of the stipulated time period, REC will have the right to cancel the order.
