
Dear Sirs,

This is with reference to limited tender enquiry of even No. dated 06-11-2009 for printing & distribution work of REC's proposed FPO. It is to inform all bidders as under:-

- 1) After Limited Tender enquiry most of the bidders sought waivers regarding Earnest Money deposit and submission of Performance Guarantee, which were considered favourably and were informed by our letter dated 18-11-2009.
- 2) Last date of submission of the bids was 23.11.2009 1400 Hrs and the bids were to be opened on the same date at 1500 Hrs. In view of the Writ petition filed by M/s. SAP Print Solutions Pvt. Ltd. before High Court of Judicature at Mumbai, the last date of the submission and opening of the bids was extended upto 30.11.2009 1400 Hrs and 1500 Hrs. respectively.
- 3) The bids of all the eight bidders were received on or before 1400 Hrs on 23.11.2009 and the bid of M/s SAP Print Solutions Pvt. Ltd has also been received on the same day as per the Hon'ble High Court of Bombay order dated 21.11.2009.
- 4) Under the circumstances, the time of opening of the bids is now extended upto 10.12.2009 at 15.00 Hrs. at REC Corporate office, New Delhi.
- 5) This is to clarify that neither any revised bids have been received till 30.11.2009, nor any revised bids will be entertained hereinafter and the date of submission of the bids is closed on 30.11.2009.
- 6) All other terms and conditions of the bids remain unchanged.
