## **2. Powers and duties of its officers and employees**

2.1 Please provide details of powers and duties of officers and employees of the Organisation.

The Corporation has well defined Organisational Structure and functions through various departments/divisions under the overall supervision of CMD as per the **Organogram**.

2.1.1. The details of administrative, financial and other powers to different category of officers at Corporate Office as well as various Project Offices are indicated in the booklet on Delegation of Powers available as *REC.RTI/Doc.5.5.3*.

## **Organisational Setup**

REC, a Public Sector Enterprise, was incorporated on July 25, 1969 under the Companies Act 1956. REC is a listed Government of India Public Sector Enterprise with a networth of Rs. 14,745 crore. Its main objective is to finance and promote rural electrification project all over the country. The Corporate Office is located at New Delhi and seventeen fully staffed Project Offices are located in different states of the country, apart from one Training Institute viz. Central Institute for Rural Electrification at Hyderabad. To focus attention on human resources development, Corporation has been sponsoring its Executives and Non-Executives to specialized Training program me conducted by various agencies and overseas organizations of repute. As on 01.07.2013 it has on its roll 637 employees, (421 Executives from different disciplines viz. Engineering, Finance, Economic and specialized cadres and 216 non-Executives).

**Salaries of the employees are highly competitive and employees are also given several generous benefits & perks. REC's performance has earned "Excellent" rating for the past several years. The Corporation was recently given an award by the Hon'ble Vice President of India for being one of the top 10 performing PSEs in the country.**
