

2. The validity of the tender shall be up-to 30 day from the opening of the tenders.
3. The rates quoted will be firm and valid for the full financial year 2007-08 as per work order. No request whatsoever for enhancement of rates will be acceded to within the period.
- 4 . Printed books shall be delivered at Corporate Office of REC at Core-4 , Scope Complex, Lodhi Road, New Delhi. In case of delay a penalty of 1% per week or part thereof subject to maximum of 5% of the total order would be levied on the printer. Payment of penalty shall not relieve the printer of his delivery obligations under the order.
5. All disputes or differences whatsoever arising between the parties out of or relating the construction, meaning and operation or effect of this contract or the breach thereof shall be settled by arbitration in accordance with the rules of arbitration of the Indian Council of Arbitration and award made in pursuance thereof shall be binding on the parties, venue of such arbitration shall be in Delhi.
6. In the event of any award by the arbitration, the payment as awarded by the arbitrator shall be made after the award is made as the rule of the Court.
7. This contract shall be governed by the Indian laws for the time being in force. However, in case of any legal proceedings, the jurisdiction of Court to decide any dispute shall be the Delhi Court.
